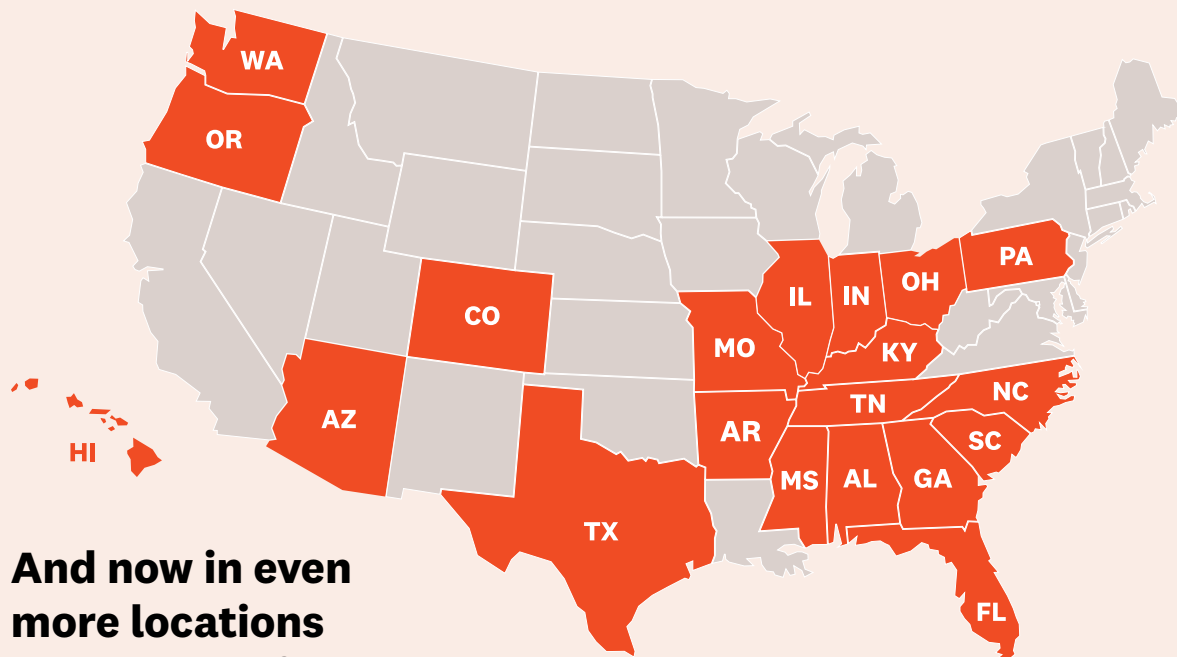

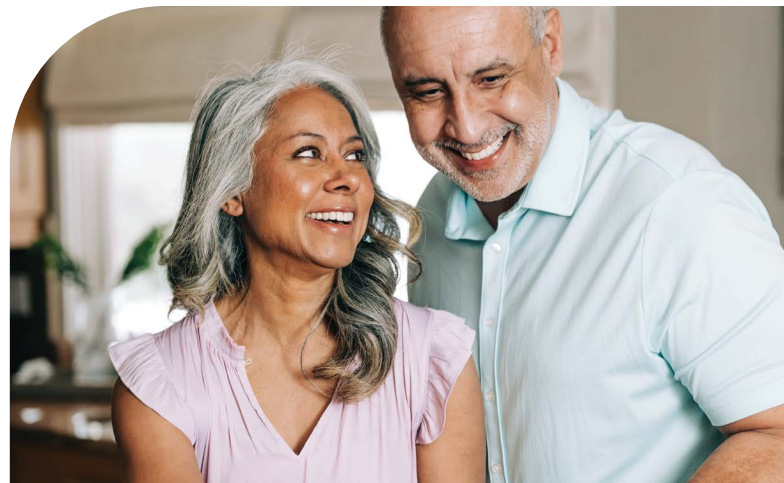
Dual special needs plans (D-SNP)

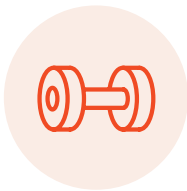

Extra Help

Extra Help is a government program. It could help you pay less for prescription drugs, prescription drug deductibles, and monthly plan premiums (if your plan has one).

Medicaid coverage

Have Medicaid? You can sign up for a dual Medicare and Medicaid plan (D-SNP). These plans could give you more extras than Medicare or Medicaid alone.

Chronic special needs plans

If you have a chronic condition like diabetes, a chronic special needs plan (C-SNP) could help you save on specialist visits, prescriptions, and more.

Helpful dates to remember

Medicare has enrollment periods. These are set windows of time when you can sign up for a plan.

7 MONTHS

Initial Election Period

When you're turning 65, you have a 7-month window to sign up for Medicare. The clock starts 3 months before the month you were born in and ends 3 months after your birthday month.

OCTOBER 15 - DECEMBER 7

Annual Enrollment Period

You can choose a new Medicare Advantage plan or switch back to Original Medicare for the next year.

JANUARY 1 - MARCH 31

Open Enrollment Period

You can change your Medicare Advantage plan or go back to Original Medicare. You can change plans only once during this period.

YEAR-ROUND

Special Enrollment Periods

You can sign up only in specific situations, like if you recently moved, or gained or lost Extra Help or Medicaid.
